The project consisted of twin Tied Arch Structural Steel Bridges spanning the Mobile River and approach bridges consisting of 148 piers ranging in height from 25 ft. to 150 ft.; 15,000 tons structural steel erection; 15,000 c.y. of concrete and 132 cofferdams from 8 ft. to 100 ft. below water surface. At the time of construction, the contract was one of the largest bridge contracts in the nation.

October 1973 – February 1977: General Manager of Burado Construction Co., a subsidiary of Wiley N. Jackson Co. of Roanoke, Virginia. Supervised all field construction operations, administration of contracts and preparations of bids.

April 1972 – September 1973: District Construction Engineer responsible for over \$250 Million of highway construction within the District. Responsibilities included the supervision of over two hundred (200) employees who made up the materials testing laboratory, survey party crews, construction division office staff, and inspectors assigned to the individual highway construction projects.

All change orders, claims, time extensions, project construction problems, negotiations and coordination with other state and federal agencies were made and/or approved at this level.
