PROFESSIONAL PROFILE

Ricky A. Langley, PE has over 22 years experience. He has most recently worked as a Resident/Senior Project Engineer for DRMP but has also worked in transportation production and operation positions throughout his career including District Secretary District One, Director of Production, District Construction Engineer, Resident Engineer, Project Engineer and Inspector for FDOT. He has diverse experience from planning to construction of transportation projects with his strengths being in Construction Engineering and Inspection. Throughout his career, Mr. Langley has obtained extensive organizational and management experience while managing work programs worth \$2.5 billion dollars.

WORK HISTORY

Mr. Langley currently serves as a Resident/Senior Project Engineer on ongoing construction projects for our CEI Division. Projects he is currently leading in FDOT District 5 include all Group 104 projects and one project from Group 98 which include projects to widen and reconstruct portions of west SR 50 in Orlando, Winter Garden and Clermont totaling approximately \$66 million. He is also currently leading one project in FDOT District One on US 98 from south of Manor Drive to North of CR 540A in Polk County. Construction of this 3.7 mile project begin in January 2011 and is anticipated to be complete in the fall of 2012. Improvements included in this project consist of widening US 98 from 4 lanes to 6 lanes, removal of old asphalt (milling) and resurfacing existing lanes, drainage, street lighting, sidewalk construction, traffic signals, signing and pavement markings.

Ricky has also previously served as the Senior Project Engineer on US 17/92 in Lake Alfred totaling approximately \$7 million for District One; new construction of OOCEA's SR 414 John Land Apopka Expressway totaling \$140 million; reconstruction and resurfacing for FDOT District Five Group 92 (State Roads 434, 426, 46 and 419) totaling \$30 million; two I-75 guardrail and signage improvement projects in Sumter County for FDOT District 5; and three intersection improvement projects for FDOT District Two in Clay and Duval Counties. Rick's duties include contract administration, performing constructability reviews, construction schedule reviews, claim analysis and reviews, maintenance of traffic reviews and QA/QC of CEI services.

Florida Department of Transportation District One, District Secretary (June 2002 to June 2004)

Mr. Langley served as the District Secretary for District One, managing the entire transportation program from planning to construction of projects, and the maintenance and operation of the entire federal and statewide transportation system for twelve counties in southwest Florida. He managed 880 employees within four different divisions. He served on the Florida Department of Transportation's Executive Board and helped in setting policy and procedure for the entire Department. His duties as District Secretary included leadership and management of the entire District while focusing on teamwork, customer needs,

continuous improvement, change management, employee motivation and obtaining results, communicating with state and local official, property owners, transportation users, transportation affiliated groups, and transportation professionals, managing a five year \$2.5 billion work program, trouble shooting the production or construction of transportation projects, giving presentations to different groups or associations, and developing viable strategies to achieve transportation objectives in District One.

Florida Department of Transportation District One, District Director of Production (April 2000 to June 2002)

Responsible for the leadership and management of the production division within District One. This division was made up of approximately two hundred employees consisting of six departments including Modal Development, Design, Right of Way Mapping and Surveying, Right of Way, Utilities and Project Management. This division was responsible for the planning, development and coordination of Federal and State transportation projects for bid and the development of contracts for grants throughout twelve counties in southwest Florida.
