 inquiring as it deems necessary relative to firms desiring
 to participate in this type of project. The bidder shall
 submit the notarized Affidavit & Profile Form (Form No.
 275-000-01), which is provided by the Department, prior
 to receipt of bid documents, attesting to meeting these
 requirements. This Initiative is being performed under the
 Departments Alternative Contracting authority provided by
 Section 337.025 Florida Statutes. This project utilizes
 Alternative bid guarantee and qualification requirements.
 Bid Bonds of \$500 are required for bids over \$150,000 and
 may be in the form of a Cashier's Check, the BDI Bond form
 (form 375-020-16) or the standard Bid Bond form (form
 375-020-09). All bidders must submit the BDI Reference sheet
