FAILURE TO FILE A PROTEST WITHIN THE TIME PRESCRIBED IN SECTION 120.57(3), FLORIDA STATUTES, OR FAILURE TO POST THE BOND OR OTHER SECURITY REQUIRED BY LAW WITHIN THE TIME ALLOWED FOR FILING A BOND SHALL CONSTITUTE A WAIVER OF PROCEEDINGS UNDER CHAPTER 120, FLORIDA STATUTES. THIS NOTICE IS NOT INTENDED AS AN ACCEPTANCE OF ANY OFFER CREATED BY SUBMISSION OF A BID, AND NO CONTRACT SHALL BE CONSIDERED TO EXIST UNTIL REDUCED TO WRITING AND EXECUTED BY ALL PARTIES THERETO.
