1095 Calendar Days (365 days with up to two (2) one-year Renewal Options)

Sealed bids are requested for providing disaster-related emergency Cut & Toss and Debris Removal on Federal Aid Highway segments, state, local and private roadways within the Florida Department of Transportation's District Six (Department) or other locations as determined by the Project Manager. The contractor shall provide all equipment, supplies, and personnel necessary to complete the services described in Exhibit A - Scope of Services. The Department may award one or more contracts for this project.

**PREQUALIFICATION REQUIREMENT:** Contractors must be prequalified by the Department in Debris Removal to receive the bidding documents. **SPECIAL NOTES:**

- No Bid Bond required
- No Pre-bid Conference
- Work will begin contingent upon legislative budget approval and availability of funds
- Awarded Contractor(s) must execute documents within five (5) work days; excluding weekends and state holidays
- Awarded Contractor(s) must provide and keep in force throughout the term of the contract General Liability and Workman's Compensation Insurance. The State of Florida Department of Transportation shall be endorsed as additional insured with regards to general liability insurance. Effective immediately, the Department will not accept insurance policies per this section that include commercial general liability coverage with a deductible, retention or self-insured retention feature. This does not include other insurance such as automobile, umbrella, or excess coverage that the contractor may also have obtained.
- Upon execution of the contract, the contractor must supply the Department with a letter from a surety authorized to do business in the State of Florida, verifying the contractor is bondable in the State of Florida in an amount equal to or greater than the amount of the original contract. The performance bond will be required when work is authorized.
