- The prime contractor must be pre-qualified with the FDOT in **Traffic Signals** and **Roadway Signing** or have been actively engaged in the business of roadway maintenance and/or construction performing traffic signal repair/installation and/or single and multi-post sign repairs for a minimum of three years. Form "F", Experience worksheet is provided in the bid documents for the bidder to provide a minimum of three references for which your company has performed traffic signal repair/installation and/or single and multi-post sign repairs repair work within the last three years. All references will be checked and a bid proposal may be considered non-responsive if the above information is not provided with your bid submittal.

- There will be no pre-bid conference.
- Prior to execution of the contract, a corporation must show proof that it is authorized to do business in the State of Florida. Florida Corporations should provide copy of the Certificate of Incorporation and Foreign Corporations should provide copy of Certificate of Authority from the Florida Department of State.

- After awarded contracts are e-mailed to contractors, signed contracts must be returned within ten (10) calendar days, excluding Saturdays, Sundays, and state holidays, with General Liability and Worker's Comp Insurance.
- Work cannot begin until written authorization is given.
- Contractor will supply a letter to the Department upon execution of this agreement, from a surety authorized to do business in the State of Florida, verifying the contractor is bondable in the State of Florida.
- Contracts executed will require a performance bond when authorization is written.
- All State and Federal rules and regulations apply.
- Multiple Contracts may be awarded for each category.

**BID REJECTION:** The right is reserved to reject any or all bids. The department will accept fax proposal (bid) revisions at fax # 813-975-6490, if received in full by 11:00 A.M. (Local Time) on the day of the letting. A faxed proposal (bid) revision will not be considered if received at a different fax number.
