 Work consists of providing all labor, materials, equipment and incidentals necessary for the reconstruction of approximately 6.5 miles of the existing northbound Turnpike three-lane section to six lanes from Sunrise Boulevard to Atlantic Boulevard (County MP 12.484 to County MP 18.934). In addition, existing structures, interchange ramps, the Mainline Toll Plaza and side roads will be modified to accommodate the proposed section. An additional through lane will be constructed to the outside in the northbound direction. The existing three-lane roadway will be milled and resurfaced. Sound Barrier walls and other improvements (drainage, signing, landscaping, retaining walls, bridge widening and lighting) are included within these limits that support the widening of the Mainline.
