Work consists of providing all labor, materials, equipment and incidentals necessary for the improvements on SR 869 (Sawgrass Expressway) between the City of Parkland and the City of Coral Springs in Broward County, in Section 4, Township 48 South, Range 41 East. The project limits on SR 869 are between Sta. 830+53.95 (MP 14.624) to Sta. 918+30.00 (MP 16.286), a net length of 1.662 miles. The improvements under this Contract consist of addressing the overall stability of the embankment slopes behind existing noise walls throughout the reaches of the adjacent canals. These improvements are critical to protecting both the adjacent noise walls and roadway, and to provide a safe environment for maintenance operations. The project consists of repair of the canal slopes that have suffered severe erosion along some sections of Noise Wall 3 located between Pine Island Road and University Drive (Sta. 848+40 to Sta. 870+20) and Noise Wall 6 located east of University Drive (Sta. 888+40 to Sta. 918+30). No Pre-Bid Conference. Contractor must be prequalified.
