Escambia and Santa Rosa County Traffic Alert

Chipley, FL – Drivers will encounter traffic disruptions on the following state roads in Escambia and Santa Rosa counties as crews perform construction and maintenance activities.

- U.S. 98 Resurfacing, Santa Rosa County U.S. 98 between Live Oaks Village shopping center and the Gulf Breeze Zoo in Santa Rosa County. Alternating lane closures from 7 p.m. to 7 a.m. Friday, Nov. 13 through Thursday, Nov. 19. Crews will be placing the final layer of asphalt on the roadway and completing work list items.
- U.S. 98 Pensacola Bay Bridge. Eastbound lane restrictions 9 a.m. to 3 p.m. Sunday, Nov. 15 as crews perform a routine inspection at the center of the span.
- I-10 between Davis Highway (Exit 13) and Scenic Highway (Exit 17), Escambia County- Alternating lane closures from 8 p.m. to 6:30 a.m. the week of Monday, November 16 as crews shift traffic to the outside to begin widening work in the median.
- I-10 Six Lane, Santa Rosa County I-10 east and westbound between the Escambia Bay Bridge and S.R. 281 (Avalon Boulevard) in Santa Rosa County. Alternating lane closures Sunday through Thursday through the end of 2015. Lane closures will be in effect from 8 p.m. to 6 a.m. as crews perform construction activities.
- Nine Mile Road from west of I-10 to Heritage Oaks Drive, Escambia County -Eastbound and westbound lane closures from 8 p.m. to 6 a.m. through Sunday, Nov. 22 as crews perform paving operations.

- **I-110 Bridge Painting** Drivers may encounter intermittent daytime restrictions on city streets under I-110 between Maxwell and Garden Streets as crews clean the bridges. The \$2.6 million rehabilitation project is anticipated to be complete summer 2016.
- S.R. 95 (U.S. 29) from north of Champion Drive to the Alabama State Line Lane closures, Monday, Nov. 16 to Friday, Nov. 20 from 9 a.m. to 3 p.m. in the northbound outside lane of U.S. 29 beginning at Upton Street. Construction crews are replacing curb and gutter, sidewalk, curb ramps and pedestrian handrails.
- S.R. 87 north of U.S. 98 in Santa Rosa County New driveway connection construction at the Navarre RV/Boat Storage facility, through Nov. 22. Lane closures in effect 8 p.m. to 6 a.m.

Drivers are reminded to use caution, especially at night, when traveling through a work zone.

All planned construction activities are weather dependent and may be re-scheduled in the event of inclement weather.

Lane closures in Big Bend Area

Chipley, FL - The following construction activities are taking place on state roads in the Big Bend Area:

- State Road (S.R.) 30 (U.S. 98) from west of County Road (C.R.) 384 to the Apalachicola River Bridge in Franklin County. Crews are performing sidewalk construction and resurfacing along the corridor. Watch for alternating lane closures.
- S.R. 12 from U.S. 90 to U.S. 27 in Gadsden County. Drivers will encounter intermittent lane closures on S.R. 12 from Madison Street to King Street and from Duval Street to Love Street in Quincy. Crews are paving and milling and working on sidewalks, curbs and gutters along S.R. 12.
- S.R. 30E (Cape San Blas Road). The speed limit on S.R. 30E (Cape San Blas Road) east of the State Park entrance in Gulf County was lowered from 45 MPH to 35 MPH Wednesday, Oct. 30.
- **C.R. 12 in Liberty County** Crews are installing nearly one-mile of sidewalk near the school to connect the high school, sports complex, public library and pre-school along Harvell Street, Myers Ann Street and Michaux Road.
- Interstate 10 (I-10) Leon County Rest Areas. Rest area renovations and repairs are taking place at the I-10 rest areas in Leon County at mile marker (MM) 194. The east and westbound rest areas are closed, use the Gadsden County facility located at MM 158 for eastbound travelers and MM 166 for westbound traffic and the Jefferson County facilities at MM 233 for east and westbound traffic. Construction is anticipated to be completed winter 2015.
- **I-10 Leon County.** Temporary lane closures in the westbound lanes from mile marker 193 to mile marker 194 in Leon County, Mon., Nov. 16 from 9 p.m. to 6 a.m. Crews are removing the temporary lane shift and temporary barrier wall.

Lane Closures on Area Roads

Chipley – Drivers will encounter lane closures and temporary delays along the following local county roadways:

- State Road (S.R.) 77 near County Road (C.R.) 388 and C.R. 2300 The southbound outside lane of S.R. 77 in Southport will be closed Monday, Nov. 16 to Friday, Nov. 20, as crews continue grading and hauling material to the project site. Lane closures will remain in effect from 9 a.m. to 5 p.m.
- S.R. 30A (U.S. 98/15th Street) from west of Jenks Avenue to east of East Avenue Construction crews are performing driveway and sidewalk work along State Road (S.R.) 30A (U.S. 98/15th Street) from East Avenue to Harrison Avenue in Bay County. Drivers will encounter periodic lane closures Sunday, Nov. 15, through Friday, Nov. 20, from 7 p.m. until 6:30 a.m. in the westbound and eastbound outside travel lanes.
- S.R. 22 from U.S. 98 to west of C.R. 2315 (Star Avenue) Paving work is taking place in eastern Bay County, workers are currently performing sidewalk work and drainage improvements.
- S.R. 71 from S.R. 69 (Pear Street) to the Jackson County line Workers are paving the thirteen mile corridor in Calhoun County. Use caution while traveling.
- U.S. 231 in Alford Crews will perform striping work through Alford, until Saturday, Dec. 5 in Jackson County. Drivers will encounter temporary lane closures from 7 p.m. to 5 a.m.
- S.R. 71 from the Calhoun County line to north of I-10 Crews will perform striping, beginning through Saturday, Dec. 5 in Jackson County. Drivers will encounter temporary lane closures from 7 p.m. to 5 a.m. All planned construction activities are weather dependent and may be rescheduled in the event of inclement weather. Drivers are reminded to pay attention to the reduced speed limit when traveling through the construction area.

Okaloosa and Walton County Traffic Alert

Chipley, FL – Drivers will encounter traffic disruptions on the following state roads in Okaloosa and Walton counties as crews perform construction activities.

- U.S. 331 Choctawhatchee Bay Bridge, Walton County- Alternating lane closures on U.S. 331 across the Relief Bridge between Bay Grove Road south and the Choctawhatchee Bay Bridge (Clyde B. Wells Bridge) from 7 p.m. Saturday, Nov. 14 to 6 a.m., Sunday, Nov. 15 as crews pour concrete for the new bridge. In addition, drivers will encounter alternating lane closures on U.S. 331 across the Clyde B. Wells Bridge Monday, Nov. 16, Wednesday, Nov. 18 and Friday, Nov. 20 from 7 p.m. to 6 a.m. as crews pour concrete for the new bridge.
- I-10 from Santa Rosa County line to east of County Road 189 (Holt/exit45), Okaloosa County (4.2 miles - Crews will begin paving operations Sunday, Nov. 15 through near Holt (exit 45) moving west toward the Santa Rosa County line. Lane closures will be in effect Sunday through Thursday 8 p.m. to 6 a.m.
- I-10 from the Okaloosa County line to west of Boy Scout Road in Walton County, (12.4 miles) Lane closures, Monday, Nov. 16 to Thursday, Nov. 19, 5 a.m. to 5 p.m., as crews pave east and westbound lanes.
- State Road (S.R.) 10 (U.S. 90), east of S.R. 85 in Crestview. Race for Lace 5K, is Saturday, Nov. 14. Eastbound U.S. 90 from Industrial Boulevard to Northwest Florida State College reduced to one-lane, 8:45 a.m. to 9:45 a.m.

All activities are weather dependent and may be delayed or re-scheduled in the event of inclement weather. Motorists are reminded to use caution, especially at night, when traveling in a work zone and to watch for construction workers and equipment entering and exiting the roadway.
