# Florida Department of Transportation Combined Customer Satisfaction Survey for All Groups 2007 Statewide

The Florida Department of Transportation (FDOT) is conducting a survey to assess satisfaction with Florida's State Highway System. When filling out this survey, please think of the State Highway System as interstates or highways with U.S. numbers or S.R. numbers

Each row represents the percentage of respondents who chose a response category (strongly agree, agree, disagree, strongly disagree, no opinion) out of the total number of respondents who answered that question. Row percentages generally total 100, but due to rounding, sometimes the percentages do not total to 100. Each cell represents the percentage of respondents in each response category for each question. Columns represent the percentage of respondents that named a response category for an entire question set. Columns may be used to gain an overall assessment of how respondents viewed each section, by response category.
