SUBJECT: Temporary Lane Separator

ISSUE BACKGROUND: Effective with the January 2013 letting, Index 600 and Section 102 of the specifications were updated to include separate payment for Temporary Lane Separator. This item was previously included for payment under Maintenance of Traffic, lump sum. Note that the payment is dependent upon the valid operations:

- When used under construction contracts, the product remains the property of the contractor; payment will include Furnish, Install, and Removal. Refer to Design Standard Index 600, Sheet 11. Fixed (surface mounted) channelizing devices will be orange, or orange/white, or orange/black in accordance with the design standard.
- When used under Maintenance or Push Button contracts, the product becomes the property of the Department; payment will include Furnish, Install, Relocate, and/or Remove. A contact name and number for pick-up/delivery instructions must be included in the contract documents, for Install or Remove pay items. The color of the temporary lane separator and fixed (surface mounted) channelizing device shall be specified. Do not restrict to specific manufacturers or limit suppliers in the contract documents.

IMPLEMENTATION: Updates will be dependent upon the type of contract and letting date:

- For Construction contracts let through December 2012, payment will continue to be included under Maintenance of Traffic, LS.
- For Maintenance contracts let through December 2012, payment may be made under the new pay items shown below.
- For all contracts let January 2013 and later, payment for Temporary Lane Separator will be made under the new 102-75-A pay item shown below.

Update Pay Items: The *Basis of Estimates Manual* has been updated to reflect the above changes.

The following maintenance pay item is valid through December 31, 2012:

E102-75-1 TEMPORARY CURB (Install), LF

The following pay items are now effective for Maintenance and Push Button contracts:

102- 75- A TEMPORARY LANE SEPARATOR, LF

A= Operation

2 (F&I, remain) Maintenance and Push Button Operations only

3 (Install) Maintenance and Push Button Operations only

4 (Relocate) Maintenance and Push Button Operations only

5 (Remove) Maintenance and Push Button Operations only

The following pay item is effective January 2013 for Construction contracts:

102- 75- A TEMPORARY LANE SEPARATOR, LF

A= Operation

1 (F&I, remove) Construction MOT Operations only

Update Plans and Pay Item Notes: For applicable projects, update the Proposal Summary of Quantities (Trns•port report) in the plans.

Specifications: Specifications will be available with the January 2013 workbook.
