Comment: (5-22-14)

Raised Strips are paid per set without adjustment due to width of pavement (lane or shoulder) receiving the strips or length of strips. Cut Strips are closely length and width defined by Index 518, pair for per mile. Is it worth noting that Cut Strips are paid for by *roadway* mile – to clearly indicate that the measurement is *not* the total length of Cut (approximately two feet per cut)?

Perhaps "The quantity of ground-in *shoulder* rumble strips to be paid for under this Section will be the plan quantity in *roadway shoulder* miles, constructed and accepted. The plan quantity will be determined based on the roadway length minus bridge lengths for each shoulder on which rumble strips are to be constructed."?

Section 546-3.3 Ground in Rumble Stripe refers to applying thermoplastic pavement markings in accordance with Section 711 over the top of the rumble strip as shown in Design Standards, Index No. 518 but that index does not address edge line rumble strip markings. It shows the rumble strips offset 14 inches from the painted edge line not under the painted strip.
