Why does the existing language need to be changed? **To clarify payment. Existing language is per set per day and is difficult to estimate, because there are two options to choose from with differing quantities – 3 sets of 3 per direction if using the internally ballasted or 4 sets of 4 per direction if using the thermoplastic type.**

Summary of the changes: **Payment will no longer be per set per day. Payment will be per day regardless of the number of sets used.**

102-11.21 Temporary Raised Rumble Strips: The quantity to be paid for will be the number of *calendar days, or portions thereof, that* temporary raised rumble strip sets *are* certified as installed/used on the project ~~on any calendar day or portion thereof~~ within the Contract Time. *The number of strips used must meet the requirements of the Design Standards, Index No. 600. No adjustment will be made to the per day measurement for the number of strips or sets used, or the number of times the sets are relocated.*
