ARTICLE 536-5 is deleted and the following substituted:

536-5 Erection of Rail.

Erect the guardrail panels, supports, anchors, etc., as shown in the Design Standards.

Where necessary to enlarge or add holes to galvanized guardrail, the work will be done by drilling or reaming. Damaged galvanized guardrail will be metalized in accordance with Section 562 and 971. No burning of holes will be permitted.
