This specification change is necessary to correct an error in Subarticle 102-11.4 that inadvertently inserted a changed intended as 102-11.14 for Arrow Boards as 102-11.4, thus unintentionally deleting 102-11.4 Commercial Material for Driveway Maintenance.

SUBARTICLE 102-11.4 (Page 120) is deleted and the following substituted:

102-11.4 ~~Arrow Board:~~ ~~The quantity to be paid at the contract unit price will be for the number of arrow boards certified as installed/used on the project on any calendar day or portion thereof within the contract time.~~

Commercial Material for Driveway Maintenance: *The quantity to be paid for will be the certified volume, in cubic yards, of all materials authorized by the Engineer, acceptably placed and maintained for driveway maintenance. The volume, which is authorized to be reused, and which is acceptably salvaged, placed, and maintained in other designated driveways will be included again for payment.*

SUBARTICLE 102-11.14 (Page 122) is deleted and the following substituted:

102-11.14 ~~Advance Warning Arrow Panel~~Board:**** The quantity to be paid at the contract unit price will be for the number of ~~advance warning arrow panels~~**boards** certified as installed/used on the project on any calendar day or portion thereof within the contract time.
