Mandatory No. 1 is issued to include the above Special Provisions and Supplemental Specifications for lettings beginning July 1, 2015 and forward.

At this time, not all projects will employ electronic submittal of construction documentation. Separate Special Provisions were created for conventional and lump jobs for when electronic submittal is required.

- (1) To allow for all construction documentation to be transmitted electronically thereby creating a paperless environment for conducting business on a project by project basis.

FHWA approval for these proposed revisions had not been received prior to the release of the July 2015WB and eBook due to production delays of the specification revisions.

- (2). To modify the Specification language to include language previously included in the Plan notes. The revisions are proposed in an effort to ensure consistency statewide.
- (3) To modify the Specification language to release the Contractor of all responsibility for establishment and maintenance of landscape items after Final Acceptance of the Contract when landscaping is less than \$100,000 or less than 10% of the roadway construction Contract.
- (4). To modify the Specification language for consistency with revisions to the Design Standards implemented with the release of Roadway Design Bulletin 15-02, Roadway Design Bulletin 15-03, and Development Design Standard Index No. D519, released on January 22, 2015.
- (5). To modify the Specification language for consistency with revisions to the Design Standards implemented with the release of Roadway Design Bulletin 15-02 on January 22, 2015.
