A RESOLUTION AUTHORIZING EXECUTION OF UTILITIES RELOCATION MASTER AGREEMENTS FOR THE ADJUSTMENT, CHANGE OR RELOCATION OF CERTAIN UTILITIES WITHIN THE RIGHT-OF-WAY LIMITS OF THE STATE HIGHWAY SYSTEM, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Department proposes to engage in certain projects for constructing, reconstructing or otherwise changing a portion of the State Highway System, which shall call for the location, protection, and/or relocation and adjustment of the City of Auburndale utilities on said Projects; and

WHEREAS, the plans for the said construction, reconstruction or other changes are to be reviewed by the State of Florida Department of Transportation and the City of Auburndale; and
