PROFESSIONAL EXPERIENCE

- 2000-Pres. *Director, Department of Public Works, Treasure Island, FL*
Manage a 49 FT, 18 PT full-service DPW responsible for: sewer collection and transmission to treatment; solid waste pick-up and removal; building maintenance; grounds maintenance; vehicle and equipment maintenance; toll collection; road and bridge repair; drainage collection, treatment and disposal; and beach maintenance. Also serve as City Engineer. Project Manager/Owner's Representative for the City's \$67M Treasure Island Causeway Bridge Replacement Project; the first phase of which is completed and the last phase (the Bascule Bridge) is under construction. Responsible for the City being LAP Certified.

The Department was funded solely by its Enterprise Funds and had annual operating costs of \$20M and an annual CIP of \$4M.

Managed 29 FT union and non-union employees in Highway, Solid Waste, Sewer & Cemetery Divisions. Reported directly to the Board of Selectmen. As Town Engineer, responsible for technical reviews of all proposed subdivision and commercial site plans with report to Planning Board. By designing road reconstruction and bridge replacements and using DPW staff for construction, saved \$2M+ on the replacement of 6 bridges (the largest was a 123' single span truss) and 5 miles of road. Built a Transfer Station for Solid Waste and successfully implemented the first automated curb-side trash collection system operated by a municipality in New England.
