SUBJECT: USE OF POSITIVE SPOT TEST PG ASPHALT BINDERS

The Department has reviewed its Specification requirements for asphalt binder taking into account the current and projected issues of supply as well as assuring the quality of the asphalt binders. The Department has developed the following procedure to allow the use of asphalt binders with a positive spot test result.

Procedure for Using Asphalt Binders with a Positive Spot Test

The Department will allow the use of PG asphalt binders with a positive spot test result (AASHTO T-102) under the following conditions:

1. Tests on Pressure Aged Residue (AASHTO R-28) at 110C meet the requirements of the particular grade.
2. The certification (916-1.3.6) indicate that the PG asphalt binder was produced in conformance with 916-1, the FDOT Positive Spot Procedure, and the supplier's QC plan.

This memorandum serves as a blanket approval to process a \$0.00 specification change for on-going projects and should be attached to the Field Supplement Agreement/Work Order or Supplemental Agreement.
