Escambia and Santa Rosa County Traffic Alert

Chipley, FL – Drivers will encounter traffic disruptions on the following state roads in Escambia and Santa Rosa counties as crews perform construction and maintenance activities.

- **I-10 Widening, Santa Rosa County** – Alternating lane closures on I-10 between the Escambia Bay Bridge and State Road (S.R.) 281 (Avalon Boulevard/Exit 22) from 8 p.m. to 6 Sunday, Jan. 24 through Thursday, Jan. 28 as crews perform construction activities.
- **U.S. 90 (Scenic Highway) at the intersection of Scenic Highway Circle, Escambia County** – Emergency repair work will resume Monday, Jan. 25. New stormwater pipe will be installed beneath Scenic Highway. Traffic flaggers will be on site to assist with traffic control as construction vehicles enter and exit the work area. The repair work will take about two months to complete.
- **S.R. 4 over Escambia River, Escambia County** – Lane closures from 9 a.m. to 3 p.m. Monday, Jan. 25 and Tuesday, Jan. 26 over Escambia River, 1.5 miles east of U.S. 29, as crews perform a routine bridge inspection.
- **S.R. 742 (Creighton Road), Escambia County** – Eastbound outside lane closed near intersection of 9th Avenue from 8 p.m. to 6 a.m. Monday, Jan. 25 through Thursday, Jan. 28 as crews perform construction activities.
- **S.R. 4 over Wilson Branch and East Relief, Santa Rosa County** – Eastbound lane closure from 9 a.m. to 3 p.m. over Wilson Branch, 2.7 miles east of U.S. 29 and East Relief located 3.1 miles east of U.S. 29, Monday, Jan. 25 as crews perform routine bridge inspections.

- **I-10 Widening, Escambia County** – Alternating east and westbound lane closures near U.S. 90 (Scenic Highway/Exit 17) from 7 p.m. to 5:30 a.m. Mon, Jan. 25 through Thursday Jan. 28 as crews perform bridge deck work for the new Scenic Highway overpass. Drivers are reminded that the speed limit on I-10, between Davis Highway and Scenic Highway, is reduced to 60 mph.
- **S.R. 289 (9th Avenue), Escambia County** – Crews continue paving operations between Bayou Boulevard and Creighton Road. Lane closures will be in effect from 9 p.m. to 6 a.m. Between Bayou Boulevard and Cervantes Street, motorists will also encounter intermittent and alternating daytime lane closures as crews adjust manholes and valves.
- **I-10 over Eleven Mile Creek Bridge, Escambia County** – East and westbound traffic reduced to one lane at the bridge near exit 5 (U.S. 90 ALT/ 9 Mile Road) as crews reconstruct the bridge approaches.
- **U.S. 29, Escambia County** – Intermittent and alternating lane closures within the town of Century and from Champion Drive north continue.

All activities are weather dependent and may be delayed or re-scheduled in the event of inclement weather. Motorists are reminded to use caution, especially at night, when traveling in a work zone and to watch for construction workers and equipment entering and exiting the roadway.

Holmes and Washington County Traffic Alert

Chipley– Drivers will encounter traffic disruptions on the following state roads in Holmes and Washington counties as crews perform construction activities.

- **I-10, Walton, Washington, Holmes Counties** -Alternating east and westbound lane closures between mile marker 90 in Walton County and Exit 112 (State Road 79) in Holmes County from 7 a.m. to 5 p.m. Monday, Jan. 25 through Thursday, Jan. 28 as crews trim trees near the roadway.
- **State Road 79, Holmes County**- Intermittent and alternating lane restriction from the Florida/Alabama State line to County Road 177 beginning Monday, Jan. 25. Lane closures will be in effect from 7:30 a.m. to 4:30 p.m. for approximately one month.

All activities are weather dependent and may be delayed or re-scheduled in the event of inclement weather. Motorists are reminded to use caution, especially at night, when traveling in a work zone and to watch for construction workers and equipment entering and exiting the roadway.

Okaloosa and Walton County Traffic Alert

Chipley– Drivers will encounter traffic disruptions on the following state roads in Okaloosa and Walton counties as crews perform construction activities.

- **I-10 Resurfacing, Okaloosa County**- Intermittent and alternating east and westbound lane closures from the Santa Rosa County line to east of County Road (C.R.) 189 (Holt Exit) between 8 p.m. and 6 a.m. Sunday, Jan. 24 through Thursday, Jan. 28. Drivers are reminded the speed limit will be reduced to 60 MPH in the active work zone.
- **State Road 85N/State Road 123, Okaloosa County Multi-lane** - Two phase traffic shift on the night of Sunday, Jan. 24 and on the afternoon of Monday, Jan. 25. During the first phase scheduled for the night of Sunday, Jan. 24, southbound S.R. 85 traffic merging onto S.R. 123 will be shifted onto the newly constructed S.R. 123 roadway. Drivers may experience minor delays while the contractor completes the traffic shift. The second phase of the traffic shift will occur early in the afternoon on Monday, Jan. 25 when northbound S.R. 123 traffic will be shifted onto the newly constructed southbound roadway north of Turkey Creek and then transitioned back to the existing S.R. 85N/S.R. 123 intersection. Minor delays are expected while the traffic shift is completed.
- **I-10 Resurfacing Walton County**- Intermittent and alternating east and westbound lane closures from just west of Boy Scout Road to just east of U.S. 331 5 a.m. to 5 p.m. Sunday, Jan. 24 through Thursday, Jan. 28.
- **I-10, Walton County**- Eastbound lane closures just west of U.S. 331 (DeFuniak Springs/Exit 85) from 8 a.m. to 5 p.m. Monday, Jan. 25 and Tuesday, Jan. 26 as crews perform work in the median and along the shoulder of the roadway.

- **I-10, Walton County-** Alternating east and westbound lane closures between mile marker 90 in Walton County and Exit 112 (State Road 79) in Holmes County from 7 a.m. to 5 p.m. Monday, Jan. 25 through Thursday, Jan. 28 as crews trim trees near the roadway.
- **State Road 187 (U.S. 331 North), Walton County-** Southbound lane closure from C.R. 2A south to C.R. 2, near Paxton, from 8:30 a.m. to 3:30 p.m. Monday, Jan. 25 as crews from Chelco perform utility work.
- **U.S. 331 Choctawhatchee Bay Bridge, Walton County-** Alternating lane closures across the Clyde B. Wells Bridge from 7 p.m. to 6 a.m. Tuesday, Jan. 26 and Friday, Jan. 29 as crews place concrete for the new bridge. In addition, there will be alternating lane closures between the Relief Bridge and the Clyde B. Wells Bridge, from 7 p.m. Thursday, Jan. 28 to 6 a.m. Friday, Jan. 29 as crews perform paving operations.
- **U.S. 90 Okaloosa County-** The left turn lane to Cayson Avenue and eastbound thru lane on U.S. 90 will be closed to traffic from 8 p.m. Tuesday, Jan. 26 to 2 a.m. Wednesday, Jan. 27 as Okaloosa Gas performs utility work.

Turn Lane Construction on U.S. 90 in Milton

Chipley, FL – Crews will begin construction activities on an eastbound, left turn lane on U.S. 90 at St. Johns Street in Milton Monday, Jan. 25. Motorists can expect intermittent lane closures from 6 p.m. to 10 p.m. Monday, Jan. 25 as crews restripe the roadway and shift traffic to construct the project. Work is anticipated to be complete spring 2016.
