

SUBJECT: **Barrier Delineators on Temporary Barrier Wall**

This bulletin changes the Department's policy and requires Barrier Delineators to be used instead of Type C Steady-Burn Lights on top of temporary barrier wall. The following requirements apply to temporary barrier wall installations.

REQUIREMENTS

1. The following [Design Standards Revisions \(DSR\)](#) are released:

Index 414 - Type K Temporary Concrete Barrier System

Index 415 - Temporary Concrete Barrier

Index 600 - General Information for Traffic Control Through Work Zones

2. Delete **Plans Preparation Manual (PPM)** Volume 1, Section 10.8.1 item number 3 and replace with the following:

3. **Type C Steady-Burn**

Steady-Burn lights are to be placed on channelizing devices to delineate the traveled way on lane closures, lane changes, diversion curves and other similar conditions.

Payment shall be included in the price of the device.

COMMENTARY

The *Design Standards Revisions (DSR)* listed above replace the Type C Steady Burn Lights with Barrier Delineators for Temporary Barrier Wall applications.

Standard Specification Section 102 will be revised to modify the use of Type C Steady Burn Lights requirements and the use of Barrier delineators. The revised specification will be implemented as Mandatory Specification Revision No. 3 to the July 2014 Workbook.

IMPLEMENTATION

For projects **LET effective July 1, 2014** with temporary barrier wall, insert revised *Design Standards* Index drawings in the Plans as described in the *PPM, Vol. 2*, Section 3.6.1.
